<u>Maintenance Operative</u> – The board agreed to offer a season 6-month contract – 30 hours per week for April-October.

<u>Finance</u> – Cash flow needs to be closely monitored. We are waiting on a claim for the campsite septic tank and storm damage. GTRL will be due a compensation claims from Enercon due to downtime experience however this will not be due until the end of the year. The board discussed whether a bank loan should be investigated to have for consideration should it be necessary to support the Trust's cash position. HIE / Scot Gov grants to be considered for on-going running costs.

<u>Gardens Apprentice</u> – £15k funding has been secured, however a further £15k needs to be secured (£30k total) before the board will consider the prospect of advertising for another apprentice.

4. Achavinish Land

IW declared a conflict of interest and did not participate in the discussions. The board agreed to offer a seasonal let for Achavinish land for 2025.

5. Keill Road

The board agreed to get a formal quote for upgrading Keill brae. The Community Council will be kept informed.

6. Cross Party Group Presentation

FC is attending the CPG meeting on 1st April 2025 at Scottish Parliament. The presentation will be on the initial buyout and how the island has developed during this time. The upcoming difficulties will be presented, such as the on-going funding of the Trust.
